## **Formation for Delegates:**

The following dates have been designated in 2021 as delegate formation sessions.

As you are aware, your online attendance at <u>one</u> of the above delegate formation sessions is required in order for you to be further prepared to contribute to the work of the first Assembly of the Plenary Council.

Please choose a first, second, and third preference for your attendance at <u>one</u> of these three-day sessions and email your preferences to the Facilitation Team at <u>plenary.council@catholic.org.au</u> by <u>Sunday, 31 January 2021</u>. You will receive an immediate reply to your email to confirm that it has been received by the Facilitation Team. Following this process, the Facilitation Team will send you the session dates you have been allocated by **Monday, 22 February, 2021**.

## **Statutes and Regulatory Norms:**

At the recent meeting of the Australian Catholic Bishops Conference in November 2020, the *Statutes and Regulatory Norms* for a Plenary Council were approved. I attach to this correspondence a copy of the *Statutes and Regulatory Norms* and encourage you to make







yourselves familiar with them. In the upcoming delegate formation sessions we shall walk through the document to ensure all delegates have a clear understanding of their role, and the guiding principles of the Plenary Council.

## **Resource Material:**

Each delegate has previously been provided a reading with suggested materials to support the whole body of Delegates for the Plenary Council. I encourage you to make yourself familiar with as many of these resources as possible. I have included with this correspondence a paper I have written on the process of discernment.

I am mindful of how the impact of COVID-19 on our lives (and the need to postpone the Plenary Council Assemblies) invites us to find ways to re-focus our collective commitment to discerning the journey leading into the fist Assemblies of the Plenary Council. Commencing in 2021 all Delegates will receive, by email, your own copy of the Plenary Post each month.

In these final days of our Advent, as we wait to celebrate the birth of Jesus, let us continue to pray for one another, our church community, and the many needs of our world.
